Data protection

I consent to Erding Mallards eV, as the responsible body, using the personal data collected in the membership application, such as last name, first name, date of birth, address, e-mail address, telephone number and bank details, exclusively for the purpose of member administration, the collection of contributions and transmission of club information processed and used by the club.

A transmission of parts of this data to the respective sports associations, and the Bavarian State Sports Association e.V. (BLSV), only takes place within the framework of the purposes specified in the statutes of the sports associations or the BLSV. This data transmission is necessary for the purpose of membership administration, for the purpose of organizing games or competitions, and for the purpose of raising public funds. There is no data transfer to third parties outside of the sports associations, the BLSV, the city of Erding, the district of Erding and the Sparkasse Erding-Dorfen. There is also no use of data for advertising purposes.

Upon termination of membership, the personal data will be deleted unless they must be stored in accordance with tax regulations.

Every member has the right to information according to Art. 15 GDPR regarding the data stored about him/her by the person responsible, Erding Mallards e.V. Furthermore, each member has the right to object to the storage of data that does not have to be kept for certain periods of time within the framework of the provisions of the GDPR for the future. Furthermore, every member has the right to correct incorrect data according to Art. 16 GDPR and the right to deletion according to Art. 17 GDPR, provided there are no legal regulations to the contrary. In addition, each member has the right to restriction of processing in accordance with Art. 18 GDPR and the right to data portability in accordance with Art. 20 GDPR. The restrictions from §§ 34, 35 BDSG apply to the right to information and the right to deletion. In addition, there is a right of appeal to a data protection supervisory authority (Art. 77 GDPR in conjunction with Section 19 BDSG).
